This letter is a final response to your request for information pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, dated December 14, 2021, and received in the FOIA Service Center on December 14, 2021. Your request was forwarded to Federal Student Aid (FSA) to search for documents that may be responsive to your request.

You requested the following:

"1. All documents constituting a notice issued by the Department to an IHE between December 2018 to present, pursuant to 34 C.F.R. § 668.83, beginning an emergency action against the IHE.

2. All documents constituting a notice issued by the Department to an IHE or third-party servicer between December 2018 to present, pursuant to 34 C.F.R. § 668.83, that begins an emergency action against a servicer contracting with a Title IV-participating IHE."

FSA provided records responsive to item 1 of the request. FSA has no responsive records for item 2 of the request.
