## **Re: Freedom of Information Act Request**

Dear FOIA Public Liaison:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of the U.S. Department of Education ("ED" or "Department"), 34 C.F.R. Part 5, the National Student Legal Defense Network ("Student Defense") makes the following request for records.

## **Background**

In order to participate in any Title IV, Higher Education Act (HEA) program, an institution must be certified as eligible by the Secretary. 34 CFR § 668.13. In order to be certified as eligible for Title IV programs, the Secretary must determine that the institution of higher education ("IHE") is eligible under 34 CFR 668.8, and meets financial responsibility and administrative capacity standards. 34 CFR § 668, 34 CFR § 668.13(a), *see generally* §§ 600 et. seq.

If the Secretary determines an IHE is eligible, it will also determine the period of eligibility, which can be no longer than six years. 34 CFR §§ 668.13(b), 668.26. When the eligibility period expires, the IHE can apply for recertification to the Secretary to obtain eligibility for another time period. 34 CFR § 668.13(b). In the interim, the Secretary may certify a IHE as eligible on a month-to-month basis. *Id*.

Previously, on July 7, 2021, Student Defense submitted a FOIA request seeking a complete listing of all institutions recertified as eligible to participate in Title IV from January 1, 2021 through July 7, 2021. Student Defense submitted additional requests for updated versions of these documents on November 2, 2021, for institutions recertified in the time period from July 7, 2021 through October 31, 2021 (FOIA Request No. 22-00624-F); December 2, 2021, for institutions recertified in the time period from October 31, 2021 to November 30, 2021 (FOIA Request No. 22-01135-F); January 13, 2022, for institutions recertified in the time period from December 1, 2021 through December 31, 2021 (FOIA Request No. 22-01567-F); February 4, 2022, for institutions recertified in the time period from January 1, 2022 through January 31, 2022 (FOIA Request No. 22-01860-F); March 4,

2022, for institutions recertified in the time period from February 1, 2022 through February 28, 2022 (FOIA Request No. 22-02144-F); April 19, 2022, for institutions recertified in the time period from March 1, 2022 through March 31, 2022 (FOIA Request No. 22-02544-F); May 5, 2022, for institutions recertified in the time period from April 1, 2022 through April 30, 2022 (FOIA Request No. 22-02687-F); July 7, 2022, for institutions recertified in the time period from May 1, 2022 through June 30, 2022 (FOIA Request No. 22-03122-F); August 2, 2022, for institutions recertified in the time period from July 1, 2022 through July 31, 2022 (FOIA Request No. 22-03292-F); September 8, 2022 for institutions recertified in the time period from September 1, 2022 through August 31, 2022 (FOIA Request No. 22-03292-F); October 21, 2022 for institutions recertified in the time period from September 1, 2022 through September 30, 2022 (FOIA Request No. 23-00186-F); November 3, 2022 for institutions recertified in the time period from October 1, 2022 through October 31, 2022 (FOIA Request No. 23-00269-F); and December 13, 2022 (FOIA Request No. 23-00560-F).

# **Requested Records**

Student Defense requests that the Department produce the following records within twenty business days of the date of this request:

• A complete listing of all institutions that have been recertified as eligible to participate in Title IV, HEA programs from December 1, 2022 through December 31, 2022.

Please include any records of the following information:

- OPEID
- Institution Name
- State
- Institution Type
- Recertification Date
- Recertification Type
- Duration of New Certification
- Previous Recertification Date
- Previous Recertification Status

We also request that the Department produce these records in native format (i.e., Microsoft Excel or .csv file) in addition to (or in lieu of) producing as PDFs.

# Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency's regulations, Student Defense requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public

in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

Student Defense requests a waiver of fees because disclosure of the requested information is "in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government."<sup>1</sup> The public has a significant interest in these recertifications, particularly as many are consumers of educational programs. Records with the potential to shed light on Title IV recertifications would contribute significantly to public understanding of the IHE compliance of Title IV obligations. Student Defense has the capacity to analyze records and to use the sought records to inform public discourse regarding issues currently pending at the Department. Student Defense has the capacity to broadcast its analysis through the news, its website, and via social media—thus "significantly" contributing to the public understanding of issues present at the Department, including those raised by the Department's processes for handling FOIA requests.

<u>This request is primarily and fundamentally for non-commercial purposes.</u><sup>2</sup> Student Defense is a non-profit, non-partisan 501(c)(3) organization.<sup>3</sup> Student Defense's mission is to work, through a variety of means, to advance students' rights to educational opportunity and to ensure that higher education provides a launching point for economic mobility. We also believe that transparency is critical to fully understanding the government's role in student protections and promoting opportunity. As noted above, Student Defense has the capacity to make the information it receives available to the public through reports, social media, press releases, in litigation filings, and regulatory comments to government agencies. For these reasons, Student Defense qualifies for a fee waiver.

# Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, Student Defense provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the terms "record" in its broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To

the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments.

- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA.<sup>4</sup> It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; Student Defense has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.<sup>5</sup>
- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide requirements to manage agency information electronically,<sup>6</sup> and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled
